

ABOUT THE AGENCY

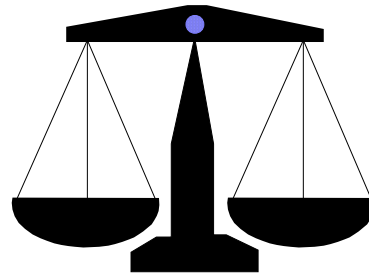
